We give God praise for all things! Camp Holiday is moving! It's time to make preparations for you to register your youth for Camp Holiday 2018 Christian Summer Camp!

Camp Holiday will have two campus locations and two camp sessions. Both locations will begin June 18, 2018. Our North Campus will remain in Temple Hills at 5833 Allentown Way, across the street from our old location. Our new South Campus will be in Waldorf, Maryland at 19 Irongate Drive. We are very excited to serve our North and South families in Prince George's and St. Charles Counties and surrounding the areas!

Camp Holiday is a free Christian Camp under the sponsorship of Community Changers Community Development Corporation (CDC). Camp Holiday has been hosting campers from the metropolitan area for the past sixteen years. The camp is for children between the ages 5-12. Camp runs Monday through Friday from 9 am to 4 pm daily.

A fee is associated with registration, which offsets the cost of transportation and staff. The registration fee for Session I is \$175.00 per camper and is non-refundable. The payment is due at time of registration. In addition to the camp hours, Camp Holiday offers Before and After Care. Before Care cost is \$45.00 weekly per camper and After Care is \$45.00 weekly per camper.

Camp Holiday 2018 Session I will begin Monday June 18, 2018, and will end Friday, August 10, 2018. Camp Holiday 2018 Session II will be August 13, 2018 through August 24, 2018. There is a \$75 fee for all campers that will attend Session II. Session II's fee is due on or before August 3, 2018. We are now receiving registration forms with the required payment and proper documentation until June 10, 2018. Due to capacity, we are only taking 45 campers at our Temple Hills (North) location. Spaces will be filled on a first come, first serve basis. Our Waldorf (South) location can accommodate over 100 campers and many youth counselors! Each camper must have a complete immunization form attached to their registration form before it can be accepted. Registration forms can be mailed to 938 East Swan Creek Road # 272, Ft. We are also looking for teenagers who would like to volunteer this year as a Camp Counselor. Also, with the application a 500-word essay entitled "Why I want to be a teen counselor at Camp Holiday?" will need to be submitted. The volunteers who are chosen will be contacted and must attend a mandatory one-day workshop/training to volunteer at Camp Holiday. The workshop is June 2, 2018, 9:30 am-noon at the Temple Hills location. Each Camp Counselor will be required to purchase a Camp Holiday t-shirt at the cost of \$15.00. T-shirt money is due on June 2, 2018.

Please note that each camper and counselor will be responsible for providing his or her own lunch and snacks daily. **Please do not send a meal that needs to be heated.** Camp Holiday will offer a continental breakfast daily for Before Care Campers and Counselors who sign in between 7am and 8:30 am. **Please make checks payable to Community Changers CDC.**
